## **Application Check List:**

**To qualify for a rebate (please see Terms and Conditions for more information):**

- This offer applies only to the City of Pleasanton water customers who have active water account(s) in good standing within the City of Pleasanton.
- Convert a *minimum* of 250 square feet of front yard lawn that is visible from a sidewalk.
- The area to be converted is currently irrigated\* and the irrigation system is in good working condition (\**exception provided under Drought Restrictions*).
- Plants installed in the converted area must be low or very low-water use and be listed on the City of Pleasanton [COP Qualifying Plant](#), [WUCOLS](#), [UC Davis Arboretum All-Stars](#), and/or [Tri-Valley Water-Wise Plant](#) lists.
- Qualified plants installed must cover at least 50% of the converted area when fully grown. **Non-permeable hardscape and artificial turf are not permitted in area to be rebated.**
- All projects must be approved and provided a Notice to Proceed from the City of Pleasanton prior to removal of the lawn to be converted. Project must be completed **within 120 days** of Notice to Proceed.
- Conversion must remain installed for a minimum of two-years.

**Funding is limited. Rebates are one-time-only per site, and will be provided on a first-come, first served basis. Applications and receipts must be postmarked, or emailed within 60 days of purchase:**

I have voluntarily determined to participate in the City of Pleasanton's Water Efficient Landscape Program. I have independently selected materials, supplies and labor for the purpose of performing the installation. I agree that all work performed will comply with applicable state and local laws, ordinances and regulations. I agree that the City of Pleasanton may visit the premises and verify existing conditions and that the work has been performed. By virtue of these inspections, I understand that the City of Pleasanton makes no determination with respect to whether materials and equipment are free of defects, the quality of the workmanship, or the suitability of the premises or the materials or equipment for the installation. I also understand that the installation of irrigation equipment and landscape materials may not result in lower water bills. If this Application is approved by the City of Pleasanton and the work proceeds, I agree to defend, indemnify and hold harmless the City of Pleasanton, its directors, officers, agents and employees against any and all loss, liability, expense, claims, suits and damages, including attorneys' fees, arising out of or resulting from the installation of irrigation equipment and landscape materials. I agree to a pre- and/or post-installation inspection, upon request.
