R.E.A.C.H. Scholarship Program **Application Guidelines 2022-2023**

Tri-Valley R.E.A.C.H. for Special Adults offers a scholarship program for people ages 15 years and above with developmental disabilities that would like to participate in the City of Pleasanton's RADD Program (Recreation for Adults with Developmental Disabilities) but may not have the financial means to do so. Participants who meet requirements are eligible to apply for the R.E.A.C.H. Scholarship.

R.E.A.C.H. SCHOLARSHIP PROGRAM

Applicants may receive scholarship funds to cover 75% of registration costs each fiscal year (July 1st-June 30th) if funds are available. Scholarships are issued for the City of Pleasanton's RADD Program registration only, not for supplies or other costs. FULL FUNDING AND PARTICIPATION IS NOT GUARANTEED.

Eligibility

1. Must provide proof of additional assistance (i.e. school-lunch program, Cal Fresh, CARE Credit, FERA Program, CA Life-Line Program, California Head Start Letter, Medi-Cal eligibility letter, Social Security/MediCal Statement, your clearance for Housing from East Bay Innovations, Proof of Housing Authority for your respective county, a current copy, etc.).

Maximum Allocation

\$250 per single household

Co-Payment

- 25% of class fees and full supply fee is required
- Recipients of the R.E.A.C.H. Scholarship or the recipient's family/guardian **must pay the co-payment at time of registration**. Scholarship recipients are not assured a place in the program and are not considered registered for a program until both their registration form(s) and the co-payment have been received. Co-payment must be in cash, valid check, or VISA, MASTERCARD or DISCOVER.

Application Process

Interested individuals/household members may turn in R.E.A.C.H. scholarship applications at any time during the year. The City of Pleasanton does not discriminate based on race, color, national origin, gender, age, medical condition, marital status, or religious belief.

- **All Fee Assistance Applications and supporting documentation are kept confidential.**
- Any past due accounts must be settled before application for the scholarship will be considered.
- RADD Activities listed in the City of Pleasanton Activities Guide are eligible for assistance.
- The Library and Recreation Department will make the final determination of funding approval based on the scholarship application and program guidelines.
- Submittal of an application is not a confirmation into the class or a confirmation of receiving the scholarship.
- Notification of R.E.A.C.H. Scholarship award is made by mail within 2 weeks of receipt of application.

- Applicants who falsify information or do not regularly attend programs for which they have been registered may become ineligible for the R.E.A.C.H. Scholarship.
